Correct Craft

(Statement)

Correct Craft, Inc., a corporation duly organized under the laws of the State of Florida, located at Pinecastle, in the county of Orange and State of Florida, and doing business at Main Street, Pinecastle, Florida, and at Yacht Basin, Titusville, Florida, has adopted and is using the trade-mark shown in the accompanying drawing, for MARINE RUNABOUTS AND CRUISERS, in Class 19, Vehicles, and presents herewith five specimens showing the trade-mark as actually used in connection with such goods, the trade-mark being applied to the goods by placing thereon a name plate upon which the trade-mark is shown, by use of decalcomania labels showing the trade-mark, and by other means customary in the trade, and requests that the same be registered in the United States Patent Office on the Principal Register in accordance with the act of July 5, 1946, section 2(f).

The trade-mark was first used by applicant's predecessor from whom title has been derived, on or about November 15, 1936, and first used in commerce among the several States which may lawfully be regulated by Congress on or about November 15, 1936.

Exclusive use of the word "Craft" is not claimed except as associated with the word "Correct," applicant's trade-mark being the composite expression "Correct Craft."

(Declaration)

W. C. Meloan, being duly sworn, deposes and says that he is the president of Correct Craft, Inc., the applicant named in the application for registration of trade-mark filed February 16, 1948, Serial No. 517,651; that he believes that said corporation is the owner of the trade-mark which is in use in commerce among the several States and foreign countries and that no other person, firm, corporation or association, to the best of his knowledge and belief, has the right to use such trade-mark in commerce which may lawfully be regulated by Congress either in the identical form thereof or in such near resemblance thereto as might be calculated to deceive, that the drawing and description truly represent the trade-mark sought to be registered, that the specimens show the trade-mark as actually used in connection with the goods, that the trade-mark has been in substantially exclusive and continuous use by the applicant for a period of five years next preceding the filing of this application in commerce which may lawfully be regulated by Congress, that the trade-mark has become distinctive of applicant's goods, and that the facts set forth in the statement are true.
